

Please read this CE Concierge End User License Agreement (“**Agreement**”) carefully before downloading or using the CE Concierge mobile software application (including all related data, associated media, and documentation, the “**Application**”) and/or learning management system (including all related data, associated media, and documentation, the “**LMS**”). As used herein, “**Product**” means either the Application or the LMS, and “**Products**” means both the Application and the LMS. This is a binding agreement between you (“**End User**” or “**you**”) and CE Concierge, a Texas limited liability company (“**CE**”, “**we**” or “**us**”), governing your use of the Products.

BY DOWNLOADING, ACCESSING OR USING A PRODUCT, YOU (A) ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND THIS AGREEMENT; (B) REPRESENT THAT YOU ARE 18 YEARS OF AGE OR OLDER; AND (C) ACCEPT THIS AGREEMENT AND AGREE THAT YOU ARE LEGALLY BOUND BY ITS TERMS. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT DOWNLOAD, ACCESS OR USE THE PRODUCTS AND, IF APPLICABLE, DELETE THE APPLICATION FROM YOUR DEVICE. We reserve the right, at our discretion, to change, modify, add, or remove portions of this Agreement at any time. Please check this Agreement periodically for changes. Your continued use of a Product following the posting of changes to this Agreement will mean you accept those changes.

1. License Grant. Subject to the terms of this Agreement, CE grants you a limited, non-exclusive, and nontransferable license to:

(a) download, install, access and/or use the Products for your personal, internal professional purposes use on a device owned or otherwise controlled by you (“**Device**”) strictly in accordance with the applicable Product’s documentation; and

(b) access, stream, download, and use on such Device the Content and Services (as defined in Section 5) made available in or otherwise accessible through the Products, strictly in accordance with this Agreement.

The Products are only intended for use on supported devices and browsers and might not work on every device and browser. Determining whether your device or browser is a supported or compatible device or browser for use of the Products is solely your responsibility, and downloading or accessing the Products is done at your own risk. CE does not represent or warrant that the Products and your device or browser are compatible or that the Products will work on your device or browser.

2. License Restrictions. You shall not:

(a) copy a Product, except as expressly permitted by this license;

(b) modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of a Product;

(c) reverse engineer, disassemble, decompile, decode, or otherwise attempt to derive or gain access to the source code of a Product or any part thereof;

(d) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices from a Product, including any copy thereof;

(e) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available a Product, or any features or functionality of a Product, to any third party for any reason, including by making such Product available on a network where it is capable of being accessed by more than one device at any time; or

(f) remove, disable, circumvent, or otherwise create or implement any workaround to any copy protection, rights management, or security features in or protecting a Product.

3. Reservation of Rights. You acknowledge and agree that the Products are provided under license, and not sold, to you. You do not acquire any ownership interest in the Products under this Agreement, or any other rights thereto other than to use the Products in accordance with the license granted, and subject to all terms, conditions, and restrictions, under this Agreement. CE and its licensors and service providers reserve and shall retain their entire right, title, and interest in and to the Products, including all copyrights, trademarks, and other intellectual property rights therein or relating thereto, except as expressly granted to you in this Agreement.

4. Collection and Use of Your Information. You acknowledge that when you download, install, access or use a Product, CE may use automatic means (including, for example, cookies and web beacons) to collect information about your Device and about your use of such Product. You also may be required to provide certain information about yourself as a condition to downloading, installing, accessing or using a Product or certain of its features or functionality, and a Product may provide you with opportunities to share information about yourself with others. All information we collect through or in connection with the Products is subject to our Privacy Policy available on our Website (as such terms are defined in Section 5). By downloading, installing, accessing, using, and providing information to or through a Product, you consent to all actions taken by us with respect to your information in compliance with the Privacy Policy.

5. Content and Services.

(a) The Products may provide you with access to CE’s website located at <https://www.ceconcierge.com/> (the “**Website**”) and certain products and services accessible thereon, and certain features, functionality, and content accessible on or through the Products may be hosted on the Website, including without limitation courses, videos, audio, articles, webcasts, and other content for continuing education requirements of licensed dentists in certain states of the United States (collectively, “**Content and Services**”). Your access to and use of such Content and Services are governed by Website’s Terms of Use located at [\[https://www.ceconcierge.com/terms-of-use\]](https://www.ceconcierge.com/terms-of-use) (“**Terms of Use**”) and Privacy Policy located at [\[https://www.ceconcierge.com/privacy-policy\]](https://www.ceconcierge.com/privacy-policy) (“**Privacy Policy**”), which are incorporated herein by this reference. Your access to and use of such Content and Services may require you to acknowledge your acceptance of such Terms of Use and Privacy Policy and/or to register with the Website, and your failure to do so may restrict you from accessing or using certain of a Product’s features and functionality. Any violation of such Terms of Use will also be deemed a violation of this Agreement.

(b) All Content and Services provided on the Products are protected by copyright and owned, controlled or licensed by CE, or the party credited as the provider of the Content and Services. You shall abide by all additional copyright notices, information or restrictions contained in any Content and Services accessed through a Product. No Content and Services from a Product may be copied, reproduced, framed, hyperlinked, modified, republished, downloaded, uploaded, posted, transmitted, or distributed in any way; provided, however, you may download, where specifically permitted, copies of the Content and Services on your Device for your personal, internal professional use only, provided you keep intact all copyright and other proprietary notices. Copying or storing of any Content and Services for other than personal, internal professional use is expressly prohibited without prior permission from CE, or the copyright holder identified in the Content and Services.

6. User Account; Reporting Requirements.

(a) If you register as a user of a Product, you will create a user ID and password that are unique to you. You are responsible for maintaining the confidentiality of the user ID and password, and responsible for all activities that occur under your user ID and password.

(b) You are advised that it is your responsibility to ensure your continuing education hours earned or tracked through the Content and Services provided in a Product are accurately and timely reported to the applicable licensing organization(s). You further acknowledge and agree that CE and its affiliates have no responsibility to confirm that you have reported such continuing education hours accurately, including

without limitation the designation of such hours for the correct category for any continuing education requirements that may apply to you, or that with respect to continuing education offered by parties other than CE and its affiliates, that such hours have been correctly described or designated by such other parties or that they meet continuing education requirements in the jurisdiction(s) where you are licensed.

7. Updates. CE may from time to time in its sole discretion develop and provide Product updates, which may include upgrades, bug fixes, patches, other error corrections, and/or new features (collectively, including related documentation, “**Updates**”). Updates may also modify or delete in their entirety certain features and functionality. You agree that CE has no obligation to provide any Updates or to continue to provide or enable any particular features or functionality. Based on your Device and/or browser settings, when your Device is connected to the internet either:

(a) the Application will automatically download and install, or the LMS will automatically refresh and/or prompt a new login, to implement all available Updates; or

(b) you may receive notice of or be prompted to download and install a new version of the Application, or to exit and re-access the LMS, to implement all available Updates.

Upon notification thereof, you shall promptly transition to the latest version of a Product and acknowledge and agree that the Product or portions thereof may not properly operate should you fail to do so. You further agree that all Updates will be deemed part of the applicable Product and be subject to all terms and conditions of this Agreement.

8. Third-Party Materials. A Product may display, include, or make available third-party content (including data, information, applications, and other products, services, and/or materials) or provide links to third-party websites or services, including through third-party advertising (“**Third-Party Materials**”). You acknowledge and agree that CE is not responsible for Third-Party Materials, including their accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality, or any other aspect thereof. CE does not assume and will not have any liability or responsibility to you or any other person or entity for any Third-Party Materials. Third-Party Materials and links thereto are provided solely as a convenience to you, and you access and use them entirely at your own risk and subject to such third parties’ terms and conditions.

9. Term and Termination. The term of Agreement commences when you download or access a Product and will continue in effect until terminated by you or CE as set forth in this Section 9. You may terminate this Agreement by deleting the Application and all copies thereof from your Device and ceasing to access the LMS. CE may terminate this

Agreement at any time without notice if it ceases to support the Products, which CE may do in its sole discretion, or if you commit a material or persistent breach of this Agreement which you fail to remedy (if remediable) within 14 days after the service of written notice requiring you to do so. In addition, this Agreement will terminate immediately and automatically without any notice if you violate any of the terms and conditions of this Agreement. Upon termination, all rights granted to you under this Agreement will also terminate and you must cease all use of the Products and, if applicable, delete all copies of the Application from your Device and account. Termination will not limit any of CE's rights or remedies at law or in equity.

10. Disclaimer of Warranties. THE PRODUCTS ARE PROVIDED TO END USER "AS IS" AND WITH ALL FAULTS AND DEFECTS WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, CE, ON ITS OWN BEHALF AND ON BEHALF OF ITS AFFILIATES AND ITS AND THEIR RESPECTIVE LICENSORS AND SERVICE PROVIDERS, EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, WITH RESPECT TO THE PRODUCTS, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, AND WARRANTIES THAT MAY ARISE OUT OF COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE, OR TRADE PRACTICE. WITHOUT LIMITATION TO THE FOREGOING, CE PROVIDES NO WARRANTY OR UNDERTAKING, AND MAKES NO REPRESENTATION OF ANY KIND THAT A PRODUCT WILL MEET YOUR REQUIREMENTS, ACHIEVE ANY INTENDED RESULTS, BE COMPATIBLE, OR WORK WITH ANY OTHER SOFTWARE, APPLICATIONS, SYSTEMS, OR SERVICES, OPERATE WITHOUT INTERRUPTION, MEET ANY PERFORMANCE OR RELIABILITY STANDARDS, OR BE ERROR-FREE, OR THAT ANY ERRORS OR DEFECTS CAN OR WILL BE CORRECTED.

SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF OR LIMITATIONS ON IMPLIED WARRANTIES OR THE LIMITATIONS ON THE APPLICABLE STATUTORY RIGHTS OF A CONSUMER, SO SOME OR ALL OF THE ABOVE EXCLUSIONS AND LIMITATIONS MAY NOT APPLY TO YOU.

11. Limitation of Liability. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL CE OR ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE LICENSORS OR SERVICE PROVIDERS, HAVE ANY LIABILITY ARISING FROM OR RELATED TO YOUR USE OF, MISUSE OF, OR INABILITY TO USE A PRODUCT OR THE CONTENT AND SERVICES FOR:

(a) PERSONAL INJURY, PROPERTY DAMAGE, LOST PROFITS, COST OF SUBSTITUTE GOODS OR SERVICES, LOSS OF DATA, LOSS OF GOODWILL, BUSINESS INTERRUPTION, COMPUTER FAILURE OR MALFUNCTION, OR ANY OTHER CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL, OR PUNITIVE DAMAGES.

(b) DIRECT, INDIRECT, SPECIAL, CONSEQUENTIAL, EXEMPLARY, INCIDENTAL, OR PUNITIVE DAMAGES ARISING FROM USER ERROR IN REPORTING CONTINUING EDUCATION CREDITS EARNED THROUGH USE OF THE CONTENT AND SERVICES ON A PRODUCT OR OTHERWISE REPORTED USING A PRODUCT.

(c) DIRECT DAMAGES IN AMOUNTS THAT IN THE AGGREGATE EXCEED THE AMOUNT ACTUALLY PAID BY YOU FOR THE PRODUCTS.

THE FOREGOING LIMITATIONS WILL APPLY WHETHER SUCH DAMAGES ARISE OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE AND REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE OR CE WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SOME JURISDICTIONS DO NOT ALLOW CERTAIN LIMITATIONS OF LIABILITY SO SOME OR ALL OF THE ABOVE LIMITATIONS OF LIABILITY MAY NOT APPLY TO YOU.

12. Indemnification. You agree to indemnify, defend, and hold harmless CE and its officers, directors, employees, agents, affiliates, successors, and assigns from and against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including attorneys' fees, arising from or relating to your use or misuse of a Product or your breach of this Agreement, including but not limited to the content you submit or make available through a Product.

13. Export Regulation. A Product may be subject to US export control laws, including the Export Control Reform Act and its associated regulations. You shall not, directly or indirectly, export, re-export, or release a Product to, or make a Product accessible from, any jurisdiction or country to which export, re-export, or release is prohibited by law, rule, or regulation. You shall comply with all applicable federal laws, regulations, and rules, and complete all required undertakings (including obtaining any necessary export license or other governmental approval), prior to exporting, re-exporting, releasing, or otherwise making a Product available outside the US.

14. Severability. If any provision of this Agreement is illegal or unenforceable under applicable law, the remainder of the provision will be amended to achieve as closely as possible the effect of the original term and all other provisions of this Agreement will continue in full force and effect.

15. Governing Law. This Agreement is governed by and construed in accordance with the internal laws of the State of Texas without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding arising out of or related to this Agreement or a Product shall be instituted exclusively in the federal courts of the United States or the courts of the State of Texas in each case located in Austin and Travis County. You waive any and all objections to the exercise of jurisdiction over you by such courts and to venue in such courts.

16. Limitation of Time to File Claims. ANY CAUSE OF ACTION OR CLAIM YOU MAY HAVE ARISING OUT OF OR RELATING TO THIS AGREEMENT OR A PRODUCT MUST BE COMMENCED WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION ACCRUES OTHERWISE SUCH CAUSE OF ACTION OR CLAIM IS PERMANENTLY BARRED.

17. Entire Agreement. This Agreement and our Privacy Policy constitute the entire agreement between you and CE with respect to the Products and supersede all prior or contemporaneous understandings and agreements, whether written or oral, with respect to the Products.

18. Waiver. No failure to exercise, and no delay in exercising, on the part of either party, any right or any power hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or power hereunder preclude further exercise of that or any other right hereunder. In the event of a conflict between this Agreement and any applicable purchase or other terms, the terms of this Agreement shall govern.

19. Notices. By downloading or accessing a Product, you authorize CE to send you (including via email and push notifications) information regarding the Products, such as: (a) notices about your use of the Products, including notices of violations of use; (b) updates to the Products and new features or products; and (c) promotional information and materials regarding CE's products and services.
